### Promotions...

The action of the Promotion Committee is to attract residents and visitors into the downtown area in order to build commerce and community use of the area through special events, retail & community events, business activities (in the role of facilitator), and image enhancement (marketing).

### Design...

The charge of the Design Committee is to facilitate the creation of an inviting, aesthetically appealing and safe downtown environment. The group promotes façade grants for improvements, reviews signage and parking needs, promotes landscaping maintenance and more.

### Economic Restructuring...

The objective of the Economic Restructuring Committee is to strengthen the existing economic assets of downtown while diversifying its economic base. The team works on business recruitment, business retention, and area demographics.

### Organizational...

The charge of this group is to maintain adequate levels of funding consistent with Main Street's annual operating budget; foster continuity, two-way communication with other local organizations at interest, the media and the general public; and coordinate the activities of all Main Street members, volunteers, and staff.
